## Bike Arlington

In Arlington, the goal is a "bikeable" community, to make that happen. Here in East Falls Church we have noticed lanes painted green to designate bike lanes, more bike lane stripings, and sharrows — areas where bikes and cars share the same lane. Many of us are not comfortable with the official integration of bicycles on our streets. Some are confused about new rules of the road. We worry that the new road markings are not convenient or safe for motorists, cyclists and pedestrians, who must now share our "complete streets."



There is no simple or single answer to what makes any community bikeable. However, there is someone who will speak

on this topic. Please join us **this Thursday** to meet David Goodman, Arlington County's Bike and Pedestrian Program Manager. Mr. Goodman will give a presentation on Walk Arlington/Bike Arlington. We can learn how the actions now underway tie into the goal of Arlington's urban villages, where goods, services, and other needs are located close to one another, to residences, and workers, and where bicycling is a safe, healthy, and enjoyable way to get around.

### ***Tuckahoe Park Update***

Mary McLean, our community's Master Naturalist Habitat Improvement Coordinator, will present a brief update and take your questions about what has been happening in Tuckahoe Park at **this Thursday's general membership meeting**. Tuckahoe Park is an extension of our homes. Neighbors love to walk there. Parents bring their kids to enjoy all parts of the park including the newly upgraded playground. Metro riders walk beside and through the park daily.

Tennis players can reserve the lit court and you can reserve tables for a place to hold picnics. There are nature trails, and you can find somewhere to just sit, collect your thoughts and reflect. We are very fortunate to have Mary McLean's devotion and expertise working for our benefit to preserve and protect Tuckahoe Park.

### ***Stewart Park Renovation Underway***

Stewart Park, located at 2400 N. Underwood Street, is four acres of fields and woods. There is a rectangular grass field, a basketball half court, a playground and a gazebo. Earlier this year the park was closed for construction and replacement of the play field, a new irrigation system and sod. The walkways and stairs will also be replaced to make the site accessible. Plans include new trash receptacles, benches, bleachers, new plantings and landscaping. The park is on target to reopen in Spring, 2015.

### ***Local Historic Designation for Benjamin Elliot's Coal Trestle***

The County Board recently approved a local historic designation of Benjamin Elliott's Coal Trestle, built in 1926 in our East Falls Church neighborhood of Arlington County. The utilitarian structure reflects our local industrial and commercial landscape and history. Such small-scale trestles were instrumental in the processing of coal for local delivery to homes and businesses. This coal trestle is a visual reminder of a critical early-20th Century energy infrastructure that powered the electrification and development of our region.

Barely visible in its present state, the trestle sits on the southern side of the Washington and Old Dominion (W&OD) Trail near the southwestern corner of Lee Highway and Fairfax Drive. The Northern Virginia Regional Park Authority (NVRPA) plans to remove invasive vines and shrubs that now block the view of the trestle and rail. Eventually, NVRPA will create an historic kiosk and display near the trestle site.
