The Next (Silver Line) Train Will Arrive in . . .

Many of us are trying to imagine what kind of impact Metro's new Silver Line will have for our community. The project has experienced many delays and false starts since its scheduled opening for early 2014. Surprisingly, however, there has been little public discussion about what we can anticipate in terms of new parking demand, car and pedestrian traffic patterns, station access, station platform improvements, and altered commuter bus routes.

The East Falls Church station will be the transfer point for those wishing to switch between the Orange and Silver lines. Commuter traffic running through that station each day will increase significantly. As a result, demand for housing anywhere near the station is expected to rise and increased density seems a given.

Our next civic association general membership meeting is Tuesday May 6, 2014 at 7:30 pm. Guest Speaker Lynn Rivers, the Arlington Coordinator and Liaison with WMATA will be on hand to discuss how the new rail service might affect our neighborhood and answer some of the questions you might have. Come out to hear what folks have to say.

Washington Blvd. Safety Concerns

Pedestrian safety on Washington Blvd. along the I-66 corridor is our number one capital project priority. This is where pedestrian traffic increases to reach the East Falls Church Metro and auto traffic speeds up. Impatient drivers jockey for position while increasing their speed to reach the onramp,

This dangerous situation will only get much worse because a second onramp lane is being added to speed the flow of traffic from Washington Blvd. onto Route 66. This work is presently being done without any improvements to address pedestrian safety issues.

This does not have to be because the EFC Plan includes several improvements to pedestrian safety. We have reached out to the County to get moving on these because VDOT is not waiting; construction is happening now.

If you want Washington Blvd. to be safe, as promised in our East Falls Church Area Plan, join us at the County Board meeting this Saturday morning, April 12, 2014.

The Westover Farmers Market is fast becoming a popular and trendy place to be on Sunday mornings. Market hours are Sunday mornings, from 9 a.m. to 1 p.m., now through April. Summer hours begin this May, from 8 a.m. to Noon. Vendors set up tents in front of the Westover Library at the corner of Washington Blvd. and N. McKinley Rd. in Arlington.

You can shop from over 15 local fruit and vegetable producers, bakers, meat producers, flower sellers, and specialty and ethnic food. This Sunday morning social event is growing so fast, in time the market is expected to expand onto the adjacent school and library grounds.

One of the most important things to know about the Westover Farmers Market is that everyone who sells at the market grows, raises, bakes, cooks, or prepares everything themselves. And it's all done within 125 miles of Arlington County. That means when you shop at this market, you are not only getting the freshest, highest-quality food, you are also meeting the people who grow it and minimizing the amount of fuel that is burned to bring it to you.
